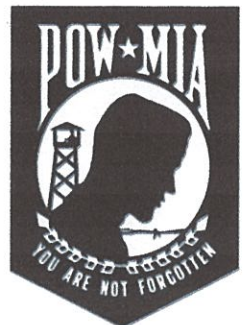

General Information

1. **Entry deadline is November 9, 2020. If you plan to participate, notify Parade Chairman as soon as possible to assist in Line-up Positioning.**
2. **Parade line-up area will be at Cochise County Fair Grounds gate 6 north entrance. Parade will run south down fairgrounds midway exiting at gate 2**
3. **American Legion Flag Etiquette will apply to everyone in the parade at all times.**
4. **Entries of participants involving vehicles or animals must at all times maintain control of such vehicle or animals.**
5. **The line-up entry numbers are to be displayed on the right front of vehicles or left side of first element of entry.**
6. **All performances and salutes will be held in front of the American Legion Post VIP seating and review area (Middle of back side of grand stands)**
7. **Participation in the parade will be at the sole discretion of the parade officials.**
